20 **INTRODUCTION OF NEW MEMBER**

22 Greg Call is a new member of the Landmarks Commission. Mr. Call is a real estate agent,  
23 and he has lived in Centerville for three years.

25 **JULY 4<sup>th</sup> BOOTH**

27 Chair Plummer sent an email to Commission members for ideas on the 4<sup>th</sup> of July booth,  
28 but the email may have been sent to late for members to review. He would like to have information  
29 on the Centerville Deuel Creek Historic District, and the contest for the new logo displayed at the  
30 booth. Information on incentives for people who are developing or doing renovations on their  
31 homes that are within the Historic District will be displayed. Information on the Historic Home  
32 Walking Tour in September will also be provided. Chair Plummer, Brent Christison, Greg Call,  
33 and Vivian Talbot will be at the booth on July 3<sup>rd</sup> and 4<sup>th</sup>. Brent Christison suggested displaying  
34 an artifact from Ron Randall's Service Station at the booth. He will talk with Ron Randall to see  
35 if he has any pictures or artifacts he would be willing to have displayed.

37 **HISTORIC HOME TOUR IN SEPTEMBER**

39 The Historic Home Tour will be on September 9<sup>th</sup>. Brent Christison volunteered to have a  
40 map enlarged and mounted of the Centerville Deuel Creek Historic District that can be displayed  
41 at the booth. A pamphlet that has the map of the Historic District and the historic homes within  
42 the Historic District will be given to individuals who are interested. Cassie Younger, Assistant  
43 Planner, will send a letter to residents before July 4<sup>th</sup> who live within the Historic District to see  
44 how many of these residents who would be willing to open their homes for the tour. Greg Call also  
45 suggested giving residents the option of having the exterior of their homes viewed if they do not  
46 want the interior to be viewed.

7           **DAVIS COUNTY COURTHOUSE**

9           Cassie Younger, Assistant Planner, reported the Davis County Courthouse is being  
10 remodeled, but the majority of the exterior will be preserved in its original state.

12           **OTHER BUSINESS**

14           Chair Plummer reported he has attempted twice to deliver the National Historic plaques  
15 for the Wayman and Smoot homes, but nobody was home.

17           Chair Plummer displayed pictures of kiosks that he has seen in other areas. Vivian Talbot  
18 suggested a kiosk be placed in the Centerville Historic Deuel Creek District by the well at the LDS  
19 Church located at 300 East and 300 South, and other designated areas yet to be determined. Brent  
20 Christison will provide costs and types of kiosks that could be used in the Historic District at the  
21 July meeting.
