21 **MINUTES REVIEW AND APPROVAL**

23 Minutes of the February 15, 2018 meeting minutes were reviewed. Mark Oligschlaeger
24 made a **motion** to approve the minutes as amended. Brandon Frederico seconded the motion,
25 which was passed by unanimous vote (4-0).

27 **REPORT ON VOLUNTEER PROJECTS**

28
29 Bruce Cox, Parks and Recreation Director, reported Rick Turner has been working on
30 volunteer projects, and Mr. Cox has been forwarding volunteer project ideas to Mr. Turner. Matt
31 Johnson said there is an Eagle Scout currently working on a project at the Freedom Hills Park.
32 There is a possible project at the top of the Parrish Lane Trailhead.

34 **REPORT ON TRAILS OPEN HOUSE**

36 Bruce Cox, Parks and Recreation Director, reported there were 200 people in attendance
37 at the Trails Open House. There were 160 comment cards completed. Estimates of residents in
38 attendance were: Eighty-percent Centerville residents, ten percent Bountiful residents, and the
39 other ten percent were residents from scattered cities. Robyn Mecham, City Council Liaison, said
40 she was amazed at how many people attended the open house, as other open houses are usually
41 not well attended. The Eagle Scout who gathered the comments, took photographs of the comment
42 cards, and he will sort the cards and present the data to the City Council at their next meeting. Mr.
43 Cox suggested members of the Trails Committee meet with members of the Gun Range Club to
44 address their concerns of the proposed trails being too close to the gun range. Bob Radke is aware
45 of the concerns of the gun range, and he will make the necessary changes on the trails plan.

1 Mr. Cox reported that years ago, a study was done on erosion control on the hillside. This
2 study will be researched to see what the findings were of that study.

3
4 At 8:40 p.m., Sunny Larson arrived at the meeting.

5
6 The gun range claims they have a lease on property that is further west than what the
7 proposed trails map is showing, and the lease area must match the gun range area. In preparation
8 for the City Council meeting next week, Mark Oligschlaeger talked today with Jeff Oyler, Davis
9 County Planning Manager, and it was agreed there is great community support for the proposed
10 trails. Mr. Cox will follow up with the State on what restrictions there might, and if there is latitude
11 if a trail needs to be changed. Robyn Meacham, City Council Liaison, said the City Council wants
12 to be certain they have all the information they need before they vote on the proposed trails. There
13 are concerns if the City Council should want to make changes on the hillside at a future date, what
14 restrictions would be in place.

15
16 Mr. Cox, reported Mr. Oyler said the County wants to partner with cities to contribute the
17 money necessary to help build the trails. The County wants to see other matching support, and not
18 just grant money. The Trails Committee discussed possible contributions of private donors, and
19 work that could be completed by volunteers.

20
21 At 9:15 p.m., Brandon Frederico was excused from the meeting.

22
23 The State grant application is due April 19th, and there are concerns the required work to
24 be done for the application can be met by this date. The County does not have a deadline on grant
25 money. Mr. Cox will research the grant further and what the rules are, and report his findings at
26 the next meeting.

27 **REPORT ON ACTIVE TRANSPORTATION PLAN GRANT**

30 Mr. Cox reported the Active Transportation Plan Grant was approved with North Salt Lake
31 and Bountiful. Each city will receive \$4,000 to be used for transportation needs. The next step is
32 to advertise for bids from planning companies.

33 **OTHER BUSINESS**

36 At the Legacy Trailhead in front of the Maverick Gas Station, there will be a kiosk in the
37 southwest corner of the intersection. Mr. Cox asked if the Trails Committee would like to have a
38 trail map in the kiosk, and be willing to maintain it. The Trails Committee agreed they will
39 maintain the kiosk.

41 Sunny Larson reported people have contacted her saying they are willing to work on the
42 Trails Committee or sub committees to help on projects.
