24 **FY 2020 BUDGET**

26 Mayor Wilkinson gave Department Heads the opportunity to comment on FY 2020
27 Department Budgets. Cory Snyder explained that the General Plan update will most likely be
28 completed near the end of FY 2020 or the start of FY 2021. Randy Randall, Bruce Cox, and Lt.
29 Zan Robison updated the Council on vehicle replacement plans. The Council and staff
30 discussed document archiving requirements and copy machine needs, as well as the idea of
31 adding an electronic sign outside City Hall to communicate information to the community. Brant
32 Hanson, City Manager, discussed with the Council the need to create a better balance between
33 openness and friendliness of design, and confidentiality and safety at City Hall.

35 **URBAN DEER PROGRAM**

37 Bruce Cox, Parks and Recreation Director, reported that the three-year Urban Deer
38 Program Certificate of Registration (COR) expires in July. Mr. Cox emphasized that Department
39 of Wildlife Resources (DWR) personnel are trained and have the right equipment to deal with
40 wildlife, while City staff do not. He recommended the City put pressure to take care of urban
41 deer back on the DWR. He said the City did not receive a lot of participation from archers in the
42 community. Mr. Cox explained the time and effort staff dedicated to the Urban Deer Program in
43 the last three years, resulting in a total of sixteen deer mitigated. He stated that to effectively
44 administer an Urban Deer Program, the City would need another staff member with training in
45 wildlife control. Councilmember Mecham requested that staff look into the sterilization option
46 used in parts of Idaho.
